

### 681 John McClure Family

John McClure was born in North Carolina 21 May 1801. He is believed to be the son of Thomas McClure who resided in Union Co. (See separate Thomas McClure story.) John McClure married first Sarah [Allen]. A marriage record has not been located for this union, but it is estimated they married around 1821-22.

John and his family moved from North Carolina to Georgia in the early 1840's. He owned lots or parts of lots 54, 37, 35 and 55 existing in Union Co. until incorporated into Towns Co. at its formation.

This land involved John and his family in court disputes that spanned nearly ten years. Robert Erwin petitioned the court in 1866 stating he was the "original owner of a bond...made and executed by John McClure, principal, and George McClure, security, made 24 January 1859 for the sum of \$535.95...said bond being due and unpaid was destroyed by the North or otherwise January 1, 1865." The court ruled this bond to be absolute in lieu of the original bond; John filed an appeal in 1867. In February 1869 John McClure made application for exemption to set apart as homestead, personal property excluded from levy and sale for the sole use of his family, lots #54 and #37; portions of which had been sold to William McClure and John McClure Jr. Other articles that were claimed as exempt were hogs, cow, farming tools, kraut stand and barrels, guinea chickens and a clock and case.

John's wife, Sarah, was deceased by this time and he had married second Margaret Gribble Clark (per Gribble family bible) between 1860-1865.

In 1870\* John and Margaret sold personal belongings and the above lots to William Patton. By the fall of 1870 John and Margaret resided in Colorado. The Sheriff seized the parcels of land in 1877 and held a public sale

by which the land was "knocked off" to William Patton for \$30.00, who was assigned the right title and interest of John McClure. John McClure died in Colorado 11 September 1881.

John and his first wife, Sarah, had the following children:

George W. married 27 Mar 1846 in Union Co. to Talitha Cami Owenby. (2) James McClure, whose birth date is recorded in the Gribble family Bible as 10 June 1825. This James has not been positively identified. (3) Rachel Matilda married 29 January 1854 to John William Gribble. (4) Joseph M. married 17 February 1861 to Mary M. (Crawford) Patton. (5) William George married circa 1858 to Sarah Jane Quarries. (6) Thomas William married 6 September 1863 to Mary Ann Elizabeth Quarries. (7) Mary Ann married in Colorado to Charles Wayman (8) Sarah Jane married 17 February 1861 to John Waldroup. (9) John; believed to be John Alexander married Martha Townsend. (10) Isabelle (11) Julia married 17 December 1868 ? to George Washington Gribble (12) Matilda Elizabeth married 15 December 1868 William Woodward Patton.

John and Margaret McClure had two children. Adeline and Charles.

## 681 JOHN McCLURE FAMILY
