

### 683 Thomas McClure

Thomas McClure came to Union County Georgia in the late 1830's, as did many friends and relatives who migrated from North Carolina. Thomas was first a landowner in Haywood County, NC on both sides of Crabtree Creek. Thomas moved to Macon County, NC about 1824, owning land on the Cartoogechaya Creek. He sold his last interests in Haywood property in 1833 and 1834.

Thomas left few records in Georgia, not unusual since he was in his declining years. He purchased Lot #35, 17<sup>th</sup> District and 1<sup>st</sup> Section in Union County in 1842 from William Kimsey. Records of this lot began as early as 1837 when Alexander Crawford sold to William B. Mann. William Kimsey then purchased the land (from Mann) in 1838, selling to Thomas McClure four years later.

Thomas McClure was born circa 1770, the son of Andrew and Mary (Wilson) McClure. Although the first wife on Thomas is unknown he likely married by 1790/91 in NC. Direct identification of all of Thomas' heirs is unclear and more evidence is necessary to establish a complete family scenario. Researched excerpts, from a letter written in 1911 by Adolphus McClure, grandson of Thomas McClure, appear to be "approximately" accurate, thus presenting only a partial family picture.

Children of Thomas and his first wife: **(1)** Andrew born circa 1796, in NC. This may be the Andrew located in Union County 1850 census married to a Lois. Veteran from War of 1812 **(2) John born 21 May 1801, in NC, died 11 September 1881, in Huerfano County, CO.** He married first, Sarah (---) circa 1822 in NC. He married second, Margaret Elizabeth Gribble Clark \* between 1860-1864. **(3)** William born 17 June 1803, in NC, died 13 November 1866, in Waynesville, Haywood County, NC. He married Nancy Leannah Corbin, 11 December 1821, in

Haywood County, NC. Thomas McClure was the Bondsman for this marriage. **(4)** Joseph born 16 July 1810, in NC, died 2 November 1855, in Fayette County, AL. He married Patience Elizabeth McLain, 29 October 1835, in AL. Joseph supposedly served in the Mexican War **(5)** Thomas (No further information), **(6)** Elizabeth born circa 1820, in NC, married first Harlan Moody 24, April 1834, in Haywood County, NC. She married, second, Ira Farmer, 9 October 1845, In Haywood County, NC.

Thomas married second, Sarah (Kirby Crawford), 25 October 1823, In Haywood County, NC. There are no known children from this union.

Sarah was born circa 1775, in VA. She died after 1860 in Union or Towns County. Sarah was the widow of George Washington Crawford Senior who died about 1820 in Haywood County, NC.

Thomas McClure's life ended in Georgia before the Civil War. In 1856 he sold his Lot #35 to Robert S. Patton (a probably step son-in-law), except for a portion of the lot deeded to John McClure (above, son) and to Enos Crawford (his step-son). Sarah (Kirby Crawford) McClure is a widow in the 1850 census in the household of Robert S and Nancy (Crawford) Patton.
